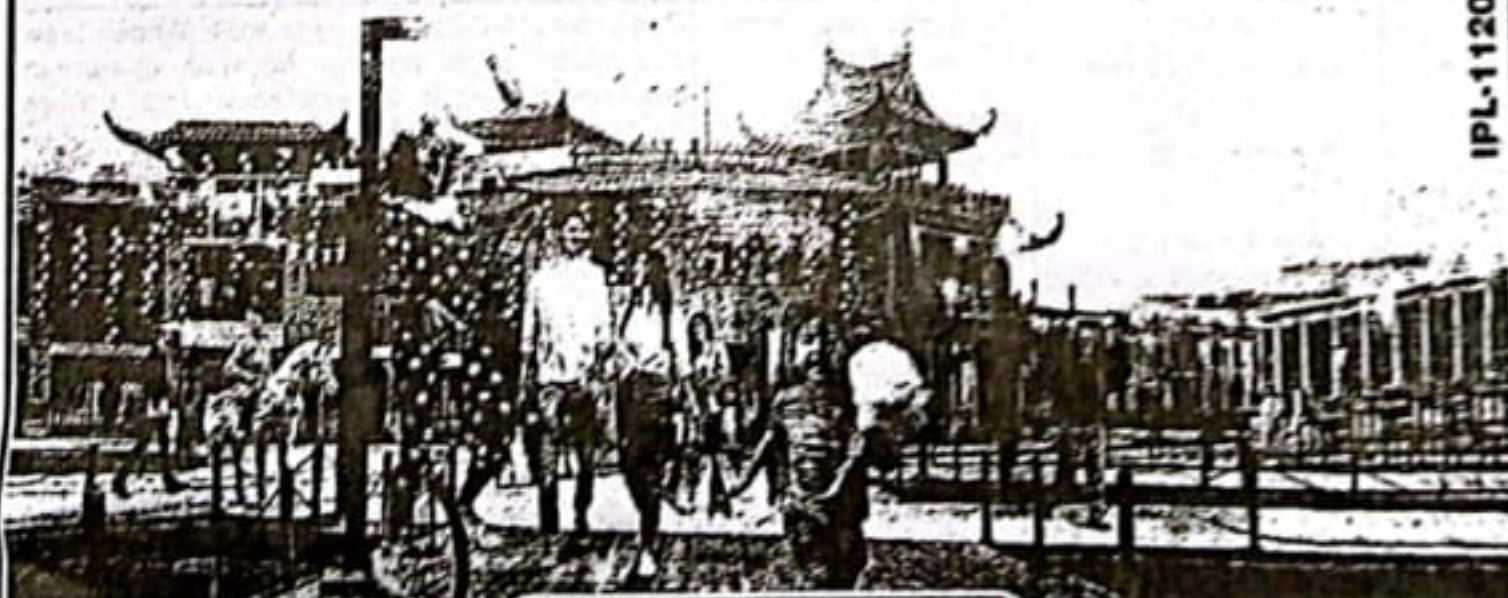
LEASE, MANAGEMENT & OPERATIONS OF LAHORE GLOBAL VILLAGE
